1 **Section 1. Be it enacted** by the County Council of Howard County, Maryland, that
2 Section 16.128 “Pre-submission Community Meetings; Exceptions.”, of Article II “Design
3 Standards and Requirements”, of Title 16 “Planning, Zoning and Subdivision and Land
4 Development Regulations”, of the Howard County Code is hereby amended to read as
5 follows:

7 **Title 16. Planning, Zoning and Subdivisions and Land Development Regulations**

8 **Subtitle 1. Subdivision and Land Development Regulations**

9 **Article II. Design Standards and Requirements**

11 **Sec. 16.128. Pre-submission community meetings; exceptions.**

12
13 *Presubmission community meeting.* The following procedures are required for a
14 presubmission community meeting:
15

16 (a) The initial plan submittal shall be as defined in section 16.108 of this
17 subtitle.
18

19 (b) The meeting shall be:
20

21 (1) Held at a location within the community, in a public or
22 institutional building located within approximately five miles of the
23 subject property; and
24

25 (2) Scheduled to start between 6:00 p.m. and 8:00 p.m. on a weekday
26 evening, or to be held between 9:00 a.m. and 5:00 p.m. on a Saturday,
27 excluding all official County holidays and Rosh Hashanah, Yom
28 Kippur, Eid Ul Fitr, Eid Ul Adha, or Chinese New Year.

29 (c) The developer shall provide three weeks advance notice regarding the
30 date, time, and location of the presubmission community meeting to be held for
31 a development project as follows:
32

1 (1) Notice shall be sent by first class mail with delivery confirmation
2 notice to:

3
4 (i) All adjoining property owners identified in the records of
5 the State Department of Assessments and Taxation; and

6
7 (ii) Any community association that represents the geographic
8 area of the subject property or any adjoining properties; and

9
10 (2) Notice shall be sent electronically to:

11
12 (i) Any community association registered with the County to
13 be notified about projects in a certain geographic area;

14
15 (ii) The Howard County Council; and

16
17 (iii) The Department of Planning and Zoning, which shall
18 place the meeting notice on the department's web site.

19
20 The property involved shall be posted with the time, date and place of the
21 initial meeting. The sign shall include the address of Department of Planning
22 and Zoning's website. The property shall be posted for at least two weeks
23 immediately before the meeting. The poster shall be double-sided and at least
24 30 inches by 36 inches in size. The poster shall include a three digit
25 alphanumeric code, which would be used to identify the case. The
26 alphanumeric code shall be posted by the Department of Planning and Zoning
27 in at least five-inch lettering in the top left corner of the poster. The
28 Department of Planning and Zoning shall determine the number of posters
29 required and their location and the petitioner shall bear the expense of posting.

1 The posters shall be erected perpendicular to the road which serves as the
2 mailing address of the subject property. The Department of Planning and
3 Zoning shall supply the posters. The petitioner shall properly erect and
4 maintain the posters.

5
6 (d) The presubmission community meeting is for the developer to provide
7 information to the community regarding the proposed development and to
8 allow community residents to ask questions and make comments. While the
9 developer is encouraged to work with the community to achieve a mutually
10 acceptable solution to any concerns, unless a change is required by this subtitle
11 or the zoning regulations, the developer is not required to change the proposed
12 development in response to comments made at the presubmission community
13 meeting.

14
15 (e) The developer shall maintain a record of the names, addresses and, if
16 available, electronic mail addresses for all attendees to the presubmission
17 community meetings, and shall compile comprehensive minutes of these
18 meetings. The developer shall prepare a written response to all of the major
19 comments recorded in the minutes. WITHIN 60 DAYS OF THE MEETING, [[The]]
20 THE developer shall send a copy of the minutes and written responses to the
21 meeting attendees [[and the department of planning and zoning]] either
22 electronically or by first class mail. Also, certification that the meeting notices
23 were mailed, [[and]] contact information for the attendees, MINUTES AND
24 WRITTEN RESPONSES shall be transmitted to the Department of Planning and
25 Zoning when initial plans are filed and shall become part of the official record.

26
27 IF THE DEPARTMENT OF PLANNING AND ZONING DETERMINES THAT THE
28 DEVELOPER FAILED TO COMPLY WITH THE ABOVE, ANOTHER PRE-SUBMISSION
29 COMMUNITY MEETING MAY BE REQUIRED AT THE DISCRETION OF THE

1 DEPARTMENT OF PLANNING AND ZONING.

2
3 (f) Citizens may request a meeting with a staff member of the Department of
4 Planning and Zoning to review the development proposal after the initial plan
5 has been formally submitted to the department.

6
7 (g) If the developer does not submit plans to the Department of Planning and
8 Zoning within one year of the presubmission community meeting, another
9 presubmission community meeting and notification in accordance with this
10 section shall be required.

14 ***Section 2. Be it further enacted*** by the County Council of Howard County, Maryland, that
15 *this Act shall become effective 61 days after its enactment.*
