1 **WHEREAS**, Section 202(f) of the Howard County Charter requires the County
2 Council to appoint a Councilmanic Redistricting Commission, not later than April 1 of the
3 year after each decennial census date; and

5 **WHEREAS**, the decennial census occurred in the year 2010; and

7 **WHEREAS**, the Councilmanic Redistricting Commission is to be made up of three
8 members nominated by the Central Committee of each political party which polled at least
9 twenty-five percent of the total vote cast for all the candidates for Office of County
10 Executive in the last preceding general election plus one member appointed by the County
11 Council; and

13 **WHEREAS**, the Central Committees of the Democratic and Republican parties in
14 Howard County are eligible and have each submitted three names; and

15
16 **WHEREAS**, the Council is required to appoint the Chairperson of the Commission
17 from among the Commission members.

19 **NOW, THEREFORE, BE IT RESOLVED** by the County Council of Howard
20 County, Maryland this ___ day of _____, 2011 that the following persons are
21 appointed as members of the Councilmanic Redistricting Commission to serve from the
22 passage of this resolution until March 16, 2012.
