1           **WHEREAS**, Section 610 of the Howard County Charter authorizes and  
2 empowers the Howard County Council to make supplementary appropriations from the  
3 unexpended and unencumbered funds set aside for contingencies in the County budget;

6           **WHEREAS**, the County has been awarded funds in the amount of \$10,006 from  
7 the Governor’s Office of Crime Control and Prevention; and

9           **WHEREAS**, specifically, the source of grant funding is the Domestic Violence  
10 Unit Pilot Program Fund created pursuant to Chapter 572 of the 2000 Laws of Maryland;

13           **WHEREAS**, grant funding will be used to fund overtime for deputy sheriffs  
14 assigned to the Domestic Violence Unit; and

16           **WHEREAS**, the Director of Finance has certified that the appropriation to be  
17 transferred is not encumbered and is available for transfer.
